1. Green Spaces - Priority

5. AECOM

AE confirmed that AECOM has had up to date plan 14th January and have given themselves 10 days to do the work required however it is hoped that it can be completed in a quicker time.

- JW to send draft letter to Natural England once it is confirmed whether an HRA is required.
- The time schedule for the referendum is dependent upon the need of the HRA.
- If HRA is required it will not be possible for the referendum to take place in May 2019.
- CW to seek clarification regarding the SEA and HRA from AECOM prior to communications with Natural England.

6. Basic Conditions Statement

- AE confirmed she is preparing the Basic Conditions Statement
- DS reported that as a result of the Sweetman Case there are now 5 Basic Conditions and HRA will now need to be covered.
