General Public

A very large number of engagements took place with the general public throughout the period of the preparation of the Neighbourhood Plan.

Street Party – 2nd June 2013

1. This event was held on Caterham High Street and Forum members spoke to people continuously throughout the afternoon. During the busiest period we had four Forum members simultaneously speaking with members of the public and each explaining the proposed NP.
2. Over the day Forum Members spoke with approximately 200 families, including young families with children below school age. The primary interests of the individuals consulted at this event were employment and education.
